

PRIVACY POLICY AND DATA PROTECTION POLICY

INITIATIVES ORGANISED OR CO-ORGANISED BY HEALTH CLUSTER PORTUGAL PRIVACY

Health Cluster Portugal informs the participants of personal data privacy policy so that they can voluntarily decide whether to provide personal information to register their enrollment. The personal data collected will be used appropriately, in accordance with the purpose for which it was collected and in compliance with the provisions of the General Data Protection Regulation - Regulation (EU) 2016/679.

DATA CONTROLLER

The data controller is Health Cluster Portugal (HCP), legal person no. 508 527 864, with headquarters at Rua da Lionesa no. 446 Loja K; 4465-671 Leça do Balio, Portugal, telephone number +(351) 220 968 183. HCP processes the data of participants and authors in a clear and responsible manner.

PURPOSES FOR WHICH DATA IS COLLECTED

This Privacy Policy applies only to the Services for the collection, use and protection of personal data for the activities of Health Cluster Portugal and third-party services fundamental to the proper execution of the same. It does not apply to websites, mobile phone/tablet applications or third-party services. We recommend that you carefully read the terms and conditions of this Privacy Policy.

INFORMATION COLLECTED

Fundamental to registration: the information collected and stored consists of personal and professional data filled in by participants and exhibitors via a form set up for this purpose, online, by email or on paper, which is used to organise and manage the registration process. This data is essential for the successful completion of the registration process for the activities.

Correspondence information: the most effective means of correspondence to and from HCP is via email: info@healthportugal.com. By registering and participating in the event, you join our mailing list, from which we will share notifications and other correspondence during the period before and after the event, as well as regarding other events organised by Health Cluster Portugal. If you wish to stop subscribing to our announcements, all you have to do is remove your e-mail address from the list in the place indicated on the announcement page. If you do not wish to receive communications from us in the future, please contact us by e-mail: info@healthportugal.com, stating your intention. Please note that requests to remove information from archive lists, although swift, can take some time to complete.

Attendance information: we do not make individualised information about participants' attendance public on any platform or place of public disclosure (e.g. social networks or website) without their prior authorisation.

Information in internal communication publications: HCP publishes in its internal communication media (HCP website and affiliates, social networks and other internal media such as newsletters) various news items from its events using audiovisual media captured by means of images, videos or audio recordings as part of the initiatives. If you do not authorise the publication of photographs, videos, and summaries, please contact HCP during the event or as soon as possible by email at info@healthportugal.com. We would also like to inform you that all participants and exhibitors, in the case of events where this is the case, are subject to image and audio capture during the Events, both by HCP and by partners, exhibitors and the media present at the event.

Therefore, if you see any material with your image/audio and do not authorise its use, please notify us (via email: info@healthportugal.com) of your request to delete it. If the image is shared on communication channels of partners and the media, please contact them, as HCP is not responsible for their content.

INFORMATION SHARED WITH:

Health Cluster Portugal: HCP has access to the information provided during the normal course of the enrollment process.

Service Providers: HCP collaborates with consortia and service providers on some projects. HCP takes the necessary measures to ensure that our service providers protect your information on behalf of HCP. If HCP becomes aware that a service provider is improperly using and disclosing information, commercially plausible measures will be taken to terminate or correct the improper use of the information.

RIGHTS

Participants can exercise their rights of access, information, cancellation, rectification, objection, processing action, data portability, opposition and automated decisions. They should claim their rights by emailing: info@healthportugal.com.

Participants also have the right to lodge a complaint with the National Data Protection Commission.

Please note that if you choose to delete your information or refuse to allow it to be collected and used, this may mean that the enrolment process cannot be considered valid.

INFORMATION RETENTION PERIOD

HCP will retain your data for as long as necessary to fulfill the purpose for which it was collected, as well as within the scope of applicable legal requirements.

INFORMATION SECURITY

HCP makes every effort to protect your information against loss, misuse, unauthorized access, alteration and destruction. We have, therefore, adopted the levels of security and data protection required by law to avoid the aforementioned issues. However, the participant and author should be aware that no data security protocol is inaccessible and, as such, HCP does not guarantee that the information cannot be accessed, collected, disclosed, violated and destroyed by unauthorised third parties acting illegitimately. In such circumstances, HCP shall not be liable for any damage caused.
